

CONSENT

of the Personal Data Subject to the Collection, Processing, Storage, and Transfer of Personal Data

I, as a personal data subject, by registering on the website and uploading personal information and/or documents, freely, of my own will and in my own interest, hereby give full and unconditional consent to Bitbanker KG LLC <https://bitbanker.kg> (hereinafter referred to as the “Platform”), in accordance with the Law of the Kyrgyz Republic “On Personal Information”, to:

1. The collection, systematization, storage, updating, use, anonymization, blocking, destruction, and other processing of my personal data provided during registration on the Platform’s website and/or in the course of using its functionality.

2. The upload, storage, and processing of documents containing my personal data, including but not limited to:

- passport or other identity document;
- personal identification number (PIN);
- photograph or other biometric image;
- information on place of registration and actual residence;
- phone numbers, email address, messengers, and other contact details;
- biographical data (date and place of birth, citizenship, marital status, education, employment, etc.);
- banking details, account information, source of funds, supporting documents (statements, certificates, payment orders, etc.);
- information on digital wallets, transactions, blockchain addresses, and virtual asset operations;
- other information necessary for identification, verification, authentication, and compliance with legal requirements (including AML/KYC), as stipulated by the Platform’s internal policies and lists, provided or to be provided by me to the Platform.

3. The transfer (including cross-border transfer) of my personal data to third parties — partners, counterparties, authorized authorities, and other entities — for purposes stipulated by the Platform’s Privacy Policy and applicable laws of the Kyrgyz Republic, including:

- user identification;
- performance of contractual and other obligations;
- compliance with legal requirements (including AML/KYC);
- providing access to Platform functionality;
- processing requests and inquiries;
- ensuring security and proper functioning of information systems.

I have been informed that:

- my personal data is processed in strict compliance with the laws of the Kyrgyz Republic, based on the principles of legality, fairness, confidentiality, and proportionality of processing purposes;

- this consent is granted for the period necessary to achieve the purposes of processing and may be withdrawn by me at any time by sending written notice to the Platform;
- withdrawal of consent may result in the inability to continue using the Platform's services;
- the Platform is obliged to ensure protection of my personal data against unauthorized access and other unlawful actions.

Prior to providing my personal data, I have familiarized myself with the list of collected data, the legal grounds and purposes of processing, possible transfer to third parties, and other conditions of data use set out in the Platform's Privacy Policy.

This consent is provided electronically by ticking the relevant checkbox during registration on the website and is recognized as a simple electronic signature equivalent to a handwritten signature and having the same legal force as a written consent.

The date of granting this consent shall be the date of registration on the Platform.
